## COMMITTED to Ensuring Our Young Families have Affordable & Available Daycare

## Problem

Grand County has 660 children under the age of 5 and currently only 41.2% (272 children) are in our 10 licensed day care centers and 1 licensed family child care home. There are currently 267 children on the waiting list for child care.

### Issue

There is a serious shortage of licensed early childhood professionals. In order for a Child Care Center to become licensed, it needs to maintain strict child to teacher ratios and all teachers must be licensed. Licensing requires 2-8 months training, plus background check and additional annual training. A beginning teacher's pay range is \$18.44 - \$26.40 per hour (\$42,661/year). The cost of living to be self-sufficient averages across Grand and Jackson County \$102,719/year for a family of 4 with young children. You can assume that the income in the Fraser Valley will need to be higher.

## Affordability

There is major gap in the average cost to families and the estimated true cost to provide care.

• Not investing in these years is a missed opportunity.


2. High-quality early childhood experiences and programs have a significant impact on children, their families, and the community:

- Increased earnings for family members, who can fill jobs in the community and increase household income; and later on, the child. This can break the cycle of poverty for families while generating more tax revenue for communities.
- Increased school readiness and social-emotional skills, decreasing use of special education, juvenile, and "welfare" services, resulting in lower expenses for communities.



## 1. Licensing is SUPER Important

- Getting licensed is the only regulatory mechanism we have to ensure the basic health and safety of children in early care and education.
- Majority of adverse outcomes occurring to children in care happens in unlicensed settings or when a provider violates licensing regulations.


## 2. Licensing is an Involved Process

- The process can take a while (2-8 months average)
- Licensing is just the beginning of a high-quality EC program.

## Early Childhood Professionals

#### 1. EC Teachers are Highly-Specialized

· So much more than "babysitters"

 Minimum teacher requirements: Fingerprints, Background Check, 15 hrs preservice training/yr, CPR/First Aid/Med Admin current, lesson planning, bachelors/associates/cda, TSG/HWT/IY/Other basic trainings (>10 full days), more on rating years/to raise PDIS level

#### 2. EC Teachers are Not Adequately Compensated

- Center Director pay: Range: \$17.54-\$37.75/hr, Average: \$27.28/hr, \$56,742/yr
- Assistant Director pay: Range: \$18.90-\$30/hr, Average: \$24.70/hr, \$51,376/yr
- Lead teacher pay: Range: \$18.44-\$26.40/hr, Average: \$21.72/hr, \$45,178/yr
- Assistant teacher pay: Range: \$18-\$26.40/hr, Average: \$20.51/hr, \$42,661/yr
- Cost of Living to Be Self-Sufficient (averaged across Grand/Jackson): \$102,719/yr for family of 4 with young children


# Early Care and Education Costs

#### For Grand County:

Age of Care	Average Cost to Families	Estimated True Cost to Provide Care
Infant Care	\$64/day (range \$40-\$90) = \$13,056/year for 4 days/week	\$107/day= \$21,828/year for 4 days/week
Toddler Care	\$60/day (range \$40-\$85) = \$12,240/year for 4 days/week	\$90/day= \$18,360/year for 4 days/week
Pre-K Care	\$48/day (range \$31-\$75) = \$9,792/year for 4 days/week	\$75/day= \$15,300/year for 4 days/week


Cost of living to be self-sufficient: \$107,484/yr for family of 4 with young children. Yet, average wages (not income) = \$45,261.

# The Early Childhood System









Our mission is to promote a child-centered school readiness system that fosters early learning, facilitates healthy child development, and promotes family success in Grand and Jackson Counties.

Grand Beginnings runs the Grand and Jackson County Early Childhood Council, a coalition of community members and leaders representing families, early childhood education, health, mental health, family and child support services, K-12 education, businesses, and local government.

We bring partners together to build the local early childhood system--this isn't our system, it is a community system.





Our Work: Strategic Priority Area-Child Health and Development

• Facilitating cross-sector, routine, standardized and universal developmental and preventive screenings (vision, oral health, and hearing) with clear referral and follow-up pathways as part of the Meeting Milestones Initiative (MMI).

• Coordinating screening and referral systems that are maintained and offered in variety of settings with data collection to remove barriers for families to access these services, also part of the Meeting Milestones Initiative (MMI).

• Providing family engagement in healthy practices, including access to healthy food, proper use of car seats and helmets, safe sleep, increased immunization rates, and physical activity.

• Ensuring most young children have access to coordinated, continuous, and comprehensive health care services through medical homes.

Value of Services Grand Beginnings Provides to Community for this Strategic Priority: \$91,477/year minimum





Our Work: Strategic Priority Area-Early Childhood Mental Health Supports

 Provide trainings and resources to EC programs to universally promote social and emotional competence to address and support children with challenging behaviors.
Provide free evidence-based early childhood mental health consultation to EC teachers, families, and young children so that EC programs have the support to address young children's mental health needs and not remove children from programs for behavior/mental health concerns.

• Facilitate preventive strategies and intervention services in the community for young children and their families to promote the positive development of their child's self-esteem and mental health. This includes providing family groups/classes such as Incredible Years, Conscious Discipline, and Circle of Security.

Value of Services Grand Beginnings Provides to Community for this Strategic Priority: \$116,000/year minimum







 $\cdot$  Employ comprehensive strategies to recruit, retain, and support a strong and qualified EC workforce.

• Provide free relationship-focused coaching, technical assistance, and support for all EC sites resulting in continuous quality improvement.

• Provide regular trainings and technical assistance to implement curriculum and best practices that support early learning, nurturing relationships, and improved child outcomes.

· Assist with licensing and opening of new EC centers and family child care homes.

 Provide and/or pay for evidence-based professional development opportunities that support qualified staff and increased Colorado Early Childhood Educator Credential Levels such as college classes and CDA certifications.

## Value of Services Grand Beginnings Provides to Community for this Strategic Priority: \$349,722/year minimum





Our Work: Strategic Priority Area-Family and Caregiver Support and Education

 $\cdot$  Provide free families engagement and education opportunities focused on school readiness, social and emotional development, positive behavior guidance strategies, relationships, and healthy practices.

• Facilitate leadership opportunities for families to advocate for their child's needs in the community.

• Advocate for and implement evidence-based strategies that reduce child maltreatment, child poverty, and increase positive parenting practices.

 $\cdot$  Fundraise and pay for our Community Tuition Assistance Program to increase the affordability of EC programs to meet family and community needs.

Value of Services Grand Beginnings Provides to Community for this Strategic Priority: \$103,000/year minimum
